Mitigation Work

 \$200 per hour for a crew of up to 4 firefighters to do mitigation work around an owner's property. Includes power tools, chainsaws, and woodchipper as needed. Work includes tree trimming, felling trees under 6" diameter, and wood chipping.

Owners requesting mitigation work need to get a written bid with an estimate and terms from the fire department before work begins. All bids include a free risk assessment for the property.

\$86.00 per month per Residential Toilet Equivalent (RTE) effective January 1, 2021

Garbage Rates:

- \$10.15 per month for each residential account (excluding lots and Sundance units)
- Commercial accounts are charged at 10 times the rate of residential accounts.

All residents with a home on their property are required to pay the garbage fees regardless of occupancy or compactor use. Owners with lots only are not permitted to use our compactor.

Fire Protection Fees:

 .1580% of the Current Market Value of each property according to the Utah County Property Assessment. This calculated value is then divided by 12 to determine the monthly charge. Effective October 2017.

* Customers wanting to use water from a fire hydrant must contact the Director of Public Works 3 business days in advance and arrange for a hydrant meter.

Use in excess of 40,000 gallons per month is not considered reasonable for customary residential use. District policy states that excessive users may be subject to termination of service.

If users are charged for water overages, and discover and repair a leak causing the overages, they may apply to the Public Works Director for a one-time 50% credit on the most recent bill.

Even if water services are terminated, homeowners are still required to pay the water fees as long as there is a working meter on their property.
